# <u>RECRUITMENT CRITERIA</u> CAREER OPPORTUNITIES AT PIDE, ISLAMABAD

Following are the criteria for the recruitment of vacant positions.

## 1. Joint Director (BPS-21)

i. The applicant must possess PhD in the field of economics, public policy, development studies, demography, business studies, environmental, health economics and any other related field to the economics from a HEC recognized university.

**RESEARCH POSITIONS** 

- ii. The applicant must have 17 years of distinguished career in a recognized national or international research/teaching institutions.
- iii. The applicant must have at least 10 research publications of the highest quality. The applicant should have published at least 04 research papers in Pakistan Development Review/internationally reputed journal of equal or higher ranking in the last 05 years.
- iv. Demonstrated ability to guide and enhance research and the capacity to handle problems of research and teaching.
- v. The opinion of three experts will be sought to evaluate the merits of his/her candidacy. The procedure for selection of the referees will be as prescribed in paragraph (iv) of the recruitment rules of the Institute for B-20.
- vi. Age limit 40-50 years

### 2. Chief of Research/Chief Training Program (BPS-20)

- i. The applicant must possess PhD in the field of economics, public policy, development studies, demography, business studies, environmental, health economics and any other related field to the economics from a HEC recognized university.
- The applicant must possess a minimum research/ teaching experience of 10 years in a recognized research/academic institution. The period will include a maximum of four (04) years spent acquiring the PhD degree. Maximum one (01) year relaxation can be given in outstanding cases.
- iii. The applicant must have at least 05productive years in BPS-19 before becoming eligible for promotion/ appointment in BPS-20.Five (05) productive years will mean that the candidate has published at least 05 substantial research articles in a regular issue of the *Pakistan Development Review*/internationally reputed journal of equal or higher rank.
- iv. A book of high professional merit may also be taken into account in determining the merit of the applicant.
- v. The opinion of three experts will be sought to evaluate the merits of his/her candidacy. The referees for such purpose will be appointed by the head of the Institute preferably from the Editorial Board of Pakistan Development Review and the Advisory Board of the Institute.
- vi. Age limit 35-45 years

### 3. Senior Research Economist (BPS-19)

- i. The applicant must possess PhD in the field of economics, public policy, development studies, demography, business studies, environmental, health economics and any other related field to the economics from a HEC recognized university.
  - a. No experience
  - b. No Publications required.

OR

- ii. Without a PhD, the applicant must have:
  - a. An applicant must possess MA/MSc (18 years' education) /All but Dissertation (ABD) status from a foreign university or MPhil from a HEC recognized national university in the field of economics, public policy, development studies, demography, business studies, environmental, health economics and any other related field to the economics.
  - b. At least 06 years of relevant research experience.
  - c. An applicant must have published at least 02 articles in a regular issue of the

Pakistan Development Review/internationally reputed journal of equal or higher rank.

- iii. Excellent written and communication skills.
- iv. Age limit 30-40 years

### 4. Research Economist (BPS-18)

- i. An applicant must possess MA/MSc (18 years' education)/All but Dissertation (ABD) status from a foreign university **OR** MPhil from a HEC recognized national university in the field of economics, public policy, development studies, demography, business studies, environmental, health economics and any other related field to the economics.
- ii. Excellent written and communication skills.
- iii. Age limit 25-35 years

### 5. Staff Economist (BPS-17)

- i. The applicant should be at least MA/MSc 2<sup>nd</sup> Class (16 years' education) in Economics, Demography, Anthropology or social science related disciplines.
- ii. Age limit 21-30 years

### 6. Professor (BPS-21)

- i. The applicant must possess PhD in the field of economics, public policy, development studies, demography, business studies, environmental, health economics and any other related field to the economics from a HEC recognized university.

The experience to be counted is of teaching/research experience in a recognized University/Institute or a post-graduate institution or professional experience in the relevant field in a national or international research organization.
- iv. 15 research publications (with at least 05 publications in the past 05 years) in HEC recognized refereed journals.
- v. Age limit 40-50 years

### 7. Associate Professor (BPS-20)

- i. The applicant must possess PhD in the field of economics, public policy, development studies, demography, business studies, environmental, health economics and any other related field to the economics from a HEC recognized university.
- ii. At least 10 years of total relevant experience, with at least four years of post-PhD experience.
- iii. The applicant must have at least 10 research publications. The applicant should have published at least 04 research papers in the last 05 years in HEC recognized refereed journals, acceptable for BPS appointments to Associate Professor.
- iv. Age limit 35-45 years

### 8. Assistant Professor (BPS-19)

- i. The applicant must possess PhD in the field of economics, public policy, development studies, demography, business studies, environmental, health economics and any other related field to the economics from a HEC recognized university.
  - a. No experience
  - b. No Publications are required.

OR

- ii. Without a PhD, the applicant must have:
  - a. An applicant must possess MPhil in the field of economics, public policy, development studies, demography, business studies, environmental and health economics from HEC recognized national university or a Masters from the foreign institution. Candidates with ABD status from foreign universities will be considered as equivalent to a foreign Masters.
  - b. At least 04 years of relevant experience.
- iii. Excellent written and communication skills.
- iv. Age limit 30-40 years

### 9. Registrar (BPS-20)

- i. The applicant must possess MA/MSc/MBAor equivalent postgraduate qualification with a 2<sup>nd</sup> class/ B-grade from HEC recognized university
- ii. The applicant must have 17 years' experience in BPS-17 and above, specially 05 years in BPS-19 in a responsible position in Government, Semi-Government teaching/research organization.
- iii. Age limit 40-50 years

### 10.Treasurer (BPS-20)

- i. The applicant must be qualified CA/ACMA/ACCA/MBA/M.Com/M.Sc Economics (1<sup>st</sup> class/A-Grade from a HEC recognized university.
- ii. The applicant must have 17 years' experience in BPS-17 and above, specially 05 years in BPS-19 in a responsible position in Government, Semi-Government teaching/research organization.
- iii. The applicant must have high academic achievements in finance, accounts, budgeting and audit with sufficient experience of working in a responsible position in Government, Semi-Government Organization or firms of repute.
- iv. Higher qualification will be given preference.
- v. Age limit 40-50 years.

### 11.Controller of Examinations (BPS-20)

- i. The applicant must possess an MA/MSc/MBAor equivalent postgraduate qualification with a 2<sup>nd</sup> class/ B-gradefrom HEC recognized university.
- ii. The applicant must have 17 years' experience in BPS-17 and above, specially 05 years in BPS-19 in a responsible position in Government, Semi-Government teaching/research organization.
- iii. Age limit 40-50 years

### 12. Literary Editor & Chief of Publications (BPS-20)

- i. The applicant must possess PhD in English or in any one of the Social Sciences with a demonstrated command over the English language.
- ii. The applicant must have an experience of 15 years with an exceptional capacity to do literary editing of a professional economics/ research journal of international repute.
- iii. The experience of supervising the production and publication of professional books, journals, magazines and reports.
- iv. Age limit 40-50 years

### 13.Additional Registrar (BPS-19)

- i. The applicant must possess MA/MSc/MBA equivalent postgraduate qualification with a 2<sup>nd</sup> class/ B-gradefrom HEC recognized university.
- ii. The candidate must have 12 years' relevant experience in BPS-17 and above on administrative/ academic or similar position in Government, Semi-Government teaching/research organization preferably in a university or DAIs.
- iii. High academic achievements in administration with sufficient experience of working in a responsible position in Government, Semi-Government teaching/research organization preferably in a university or DAIs will be preferred.

- i. The applicant must have Master degree in Mass Communication (1<sup>st</sup> Division) from a HEC recognized university/ institute.

- iii. The applicants with practical exposure of media campaigns related to socio-economic development and development of its contents.
- iv. The applicant must be able to generate and execute the impactful awareness for unserved and underserved dwellers of the country.

- v. The applicant must also have excellent communication skills, both orally and in writing.
- vi. Strong interpersonal skills.
- vii. Age limit 21-30 years

#### 15. Translator (BPS-17)

- i. The applicant must have Master degree in English/ Urdu (1<sup>st</sup> Division) from a HEC recognized university/ institute.
- ii. The applicant must have at least 02 years' experience of Translation work from Urdu to English and vice-versa rendered in Government, Semi-Government teaching/research organizations and Private Organizations.
- iii. Diploma / Professional Qualification of Translation from any HEC recognized Institution (such as NUML etc.) will be an added advantage and preferred.
- iv. Age limit 21-30 years

### 16. Computer Programmer (Graphic Designer) BPS-17

- i. The applicant must have BSc-Hons/MCS/ MSc (minimum16 year's of education) in computer sciences, graphic design or related discipline with 1<sup>st</sup> Division from a HEC recognized university/ institute.
- ii. The applicant must have at least 02 years' experience in graphic designing/ digital graphic designing, publicity, web designing rendered in Government, Semi-Government teaching/research organizations and Private Organizations.
- iii. Professional certification from any international certification agency/ HEC recognized Institution will be an added advantage and preferred.
- iv. Must have strong hands on experience of working with Adobe Photoshop, Coral Draw, Adobe illustrator, Adobe Premier, After effects, 3D (preferred knowledge of Maya, Max, Vray), In-Design, FreeHand, Inpage and MS Office.
- v. The applicant must be familiar with the social media, animations, photo/ video production and post production, motion graphics, UI/UX development, 3D (having knowledge of tools is preferred). Presentation development, Brand collaterals will be an additive advantage.
